

The Story of the ACCD Launch and the Beginning of the Journey

ACCD was established in 1987, as an Arab regional non-governmental organization, upon the initiative of HRH the late Prince Talal bin Abdulaziz Al Saud, and a recommendation issued by LAS at the "Childhood and Development" Conference held in Tunisia in 1986, to establish an Arab council for the advancement of the Arab child affairs.

The Founding Meeting of ACCD was held in Jordan (April 1987) in the presence of more than 300 experts, thinkers and public figures from 16 Arab countries and 14 international and regional organizations. This Founding Meeting resulted in announcing the establishment of ACCD, as an Arab non-governmental organization for childhood care and development, under the presidency of HRH the late Prince Talal bin Abdulaziz Al Saud. In May 1987, Egypt announced hosting the headquarters of ACCD in Cairo, and ACCD's relationship with the host country is regulated by a special agreement for this purpose with the Egyptian Ministry of Foreign Affairs that defines its identity and legal status (diplomatic body).

ACCD and the Convention on the Rights of the Child (CRC)

HRH the late Prince Talal bin Abdulaziz Al Saud believed that "care of children is the main approach to every effort that seeks to achieve real human development". In pursuit of His Highness to truly institutionalize the efforts aimed at advancing the conditions of the Arab child, especially after the tireless efforts made by His Highness all over the world when he was the UNICEF Special Envoy, HRH Prince Talal initiated the establishment of ACCD in 1987, before the adoption of the CRC by the United Nations in 1989.

Hence, the establishment of ACCD coincided with the Arab and international efforts to endorse the CRC. ACCD initiated to coordinate efforts and cooperate with LAS and UNICEF to advance the conditions of Arab childhood. In 1989, ACCD actively participated in the Arab and international activities aimed at advocating for the adoption of the CRC by the member states of the United Nations.

The philosophy of ACCD is based on creating an Arab supportive environment for child rights in development, protection, participation and inclusion. ACCD adopts a comprehensive integrated approach to ensure child rights in accordance with the CRC and the relevant international and Arab covenants, through effective cooperation and partnership with governmental, regional and international institutions.

ACCD contributes to the realization of the CRC through achieving its strategic goals, which are represented in encouraging, adopting and developing ideas, studies, projects, legislations and policies that aim at activating child rights and integrating them into development plans and projects. Moreover, ACCD seeks to achieve the sustainable development goals (SDGs) through applying its Model for Arab Child Upbringing "Education for Hope" and its components in partnership with AGFUND, the strategic partner of ACCD.



All the efforts exerted by ACCD towards the enforcement of child rights lead to the achievement of the SDGs, based on ACCD's strategic direction towards education for hope, including its approaches of the rights-based approach, empowerment, participation and self-awakening.

Based on its accumulated experience in its various practical and intellectual paths since its establishment, ACCD has formulated a developmental vision based on several intellectual circles that include: the rights-based approach, the approach of developing capacity, empowerment and participation and the approach of raising awareness and awakening the human self. As a result, ACCD was motivated to take the initiative, in partnership with AGFUND in 2014, to develop a new model for Arab child upbringing "Education for Hope" under the slogan "A New Mind for a New Human in a New Society".

The "Education for Hope" Model constitutes a coherent unit, in thought and practice, that is applied in all the programs and projects of ACCD. This approach of ACCD coincided with the global movement that was culminated in the adoption of the SDGs by all Member States of the United Nations in 2015.

Since then, ACCD is working, under the auspices of HRH Prince Abdulaziz bin Talal bin Abdulaziz Al Saud, towards implementing the "Education for Hope" Model through its strategic plans. ACCD is also updating its Model in accordance with the SDGs, especially after adding a new intellectual circle to the Model on the empowerment of Arab children in the era of the Fourth Industrial Revolution and beyond.

The "Education for Hope" Model achieves the SGDs and reflects ACCD's vision in integrated logical contexts for the Arab child development. The Model aims at developing children's awareness and awakening their creative self, in addition to unleashing their human energies and building their abilities, in order to help them live a decent life, achieve positive citizenship and empowering them in the knowledge society and in the era of the Fourth Industrial Revolution and beyond.



ACCD's Role at the Arab and International Levels:


ACCD is honored to have been established on the initiative of an exceptional, pioneering human figure, who enjoys a global and regional reputation in the fields of development, which is reflected positively on ACCD's status at the Arab and international levels. Therefore, ACCD has gained credibility and confidence at the level of Arab governments, Arab and international organizations and civil society organizations.

Since its inception more than 35 years ago, ACCD has undertaken an active role at the Arab and international levels, and has broad partnerships through joint cooperation and coordination with government agencies, national mechanisms concerned with childhood, international and regional organizations and civil society.

AGFUND is the Strategic Supporter of ACCD's Developmental Journey



AGFUND, founded by HRH the late Prince Talal bin Abdulaziz Al Saud and chaired by HRH Prince Abdulaziz bin Talal bin Abdulaziz Al Saud, is the strategic supporter of ACCD in achieving its development goals to promote the rights of the Arab child. ACCD has become the executive arm of AGFUND in the implementation of projects that target the advancement of the Arab children and the realization of their rights.



First: ACCD's Role at the Arab Level:

The League of Arab States:

- ACCD was established upon the recommendation of "Childhood and Development"
 Conference held by LAS in Tunisia in 1986. ACCD has a varied forms of cooperation with
 LAS; especially in coordinating an Arab position on the issues of the Arab child in
 international forums concerned with childhood. This cooperation was culminated in the
 signing of a joint Memorandum of Understanding between ACCD and LAS in 1993.
- ACCD has obtained a membership in the Arab Childhood Committee, affiliated to LAS, which includes the higher councils and national committees for childhood at the Arab level. This Committee undertakes the task of following up on the progress made at the level of childhood in the Arab countries.
- In 2008, ACCD has obtained the Observer Status in the Economic and Social Council of IAS
- There is an ongoing partnership with LAS in preparing strategies and implementing many projects and activities for the advancement of Arab children and the promotion of their rights. Many of these projects' outputs have been approved by the Ministerial Councils of LAS.
- The Arab Childhood Committee, affiliated to LAS, has recommended the circulation of several pilot projects of ACCD.

ACCD has multiple partnerships with several higher councils and national mechanisms concerned with childhood and civil society organizations in the Arab countries, as many joint programs, projects and activities are being implemented.

Second: ACCD's Role at the International Level:

Since its establishment, ACCD has played an active role in unifying the Arab attitude towards childhood issues at the international level, and has cooperated closely with international organizations such as UNICEF and the International Labour Organization, in coordination with LAS, in preparing documents that express Arab visions and submitting them in various international forums concerned with childhood. Such efforts have included the following:

 Drafting a Unified Arab Document for the Arab Child in coordination with LAS and submitting it at the World Summit for Children (United Nations, New York, 1990).

- Participating in the World Conference on Human Rights held in Vienna in June 1993; as ACCD took the initiative to send 17 children (boys and girls) from different Arab countries to participate in the Children's Conference accompanying this World Conference. The participating Arab children played a distinguished role in presenting their opinions and ideas that reflect the issues and problems of Arab childhood.
- Participating in the World Conference on Women in Beijing in 1995. In order to prepare for its
 participation in this Conference, ACCD held a Workshop to discuss the status of the Arab girl
 and drafted a Study entitled "The Status of the Arab Girl".
- Unifying the Arab civil effort participating in the United Nations Special Session on Children (New York - May 2002), and organizing the First Arab Regional Forum for Civil Society Forum on Childhood in Morocco in 2001, as a preparatory step for the participation in this Special Session.
- ACCD played a pivotal role in the United Nations Secretary-General's Study on Violence against Children (UNVAC) issued in 2006, through its membership in the Regional Steering Committee for the Middle East and North Africa Region. ACCD assumed the responsibility of coordinating with the higher councils and national committees for childhood in the Arab countries and following up on governments filling out the questionnaire on violence against children. ACCD actively participated in the Regional Consultative Meetings on violence against children that were held in the framework of preparing the UNVAC Study, by coordinating the efforts of civil society.
- As a result of its efforts in this field, ACCD was selected as the Representative of the Middle East and North Africa Region in the International NGO Advisory Council for Follow-up to the UN Study on Violence against Children. ACCD participated in the meetings held in New York on October 11 – 15, 2010, as well as in the meetings held in Geneva in March 2011.
- ACCD works on advocating for the international efforts to combat violence against children at
 the Arab level, throughout the cooperation with the UN Special Representative of the SecretaryGeneral on Violence against Children (SRSG-VAC), and organizing a number of meetings
 attended by the children, intellectuals, representatives of higher councils and national
 committees for childhood and civil society organizations, along with partnership with the
 SRSG-VAC in a number of campaigns and activities.
- In 2008, ACCD organized an Arab Workshop on "Discussing the Draft of the International Guidelines for the Alternative Care of Children", in cooperation with LAS. The concluding observations of the Workshop, which represent the Arab perspective, were submitted to the International Committee on the Rights of the Child, to be taken into consideration in the final draft of the Guidelines.
- ACCD celebrates the World Children's Day on November 20, by organizing events, activities
 and workshops with the children, aiming at realizing child rights. In addition, ACCD lights up its
 headquarters in blue; in order to promote international togetherness and spread awareness
 among children worldwide.
- ACCD advocates for the international campaigns on women's issues, as an inseparable part
 of childhood issues. On October 18, 2021, ACCD lit up its headquarters in pink on the occasion
 of the Breast Cancer Awareness Month.
